# 33<sup>RD</sup> ANNUAL GENERAL MEETING ("AGM") ADMINISTRATIVE NOTES FOR SHAREHOLDERS

## **Entitlement to Participate and Vote**

- (1) In respect of deposited securities, only members whose name appears on the Record of Depositors as at 30 June 2020 shall be entitled to attend the 33<sup>rd</sup> AGM or appoint proxies to attend and/or vote on his/her behalf.
- (2) If a shareholder is unable to participate at 33<sup>rd</sup> AGM, he/she may also appoint the Chairman of the meeting as his/her proxy and indicate the voting instructions in the proxy form.

### Proxy(ies)

- (1) A proxy may but need not be a member of the Company.
- (2) A member shall be entitled to appoint up to a maximum of two (2) proxies to attend and vote at the same meeting. Where a member appoints more than one (1) proxy, the appointment shall be invalid unless he specifies the proportions of his shareholdings to be represented by each proxy.
- (3) Where a member is an Authorised Nominee as defined under the Securities Industries (Central Depositories) Act 1991 ("Exempt Authorised Nominee"), which holds ordinary shares in the Company for multiple beneficial owners in one securities account ("omnibus account") there is no limit to the number of proxies which the Exempt Authorised Nominee may appoint in respect of each omnibus accounts it holds.
- (4) Where a member is an "Exempt Authorised Nominee", it may appoint at least one proxy but not more than 2 proxies in respect of each securities account it holds which is credited with the shares of the Company. The appointment of 2 proxies in respect of a particular securities account shall be invalid unless the authorised nominee specifies the proportion of its shareholding to be represented by each proxy.
- The proxy form duly completed must be deposited at the registered office of the Company at Wisma Public Packages, Plot 67 Lintang Kampong Jawa, Bayan Lepas Industrial Estate, 11900 Bayan Lepas, Penang not less than 48 hours before the time for holding the meeting or adjournment thereof, or in the case of a poll not less than 24 hours before the time appointed for the taking of the poll. Any completed Proxy Form transmitted by facsimile or electronic mail to the Office of the Company will not be accepted.
- (6) In the case of a corporate member, the proxy form must be executed under the corporation's common seal or under the hand of an officer or attorney duly authorised in which, it must be supported by a certified true copy of the relevant form or resolution appointing the officer or certified true copy of the power of attorney.

#### **Administrative Guide**

- (1) Registration will start at 9.00 am and will end at 10.00 am sharp or at such time as directed by the Chairman of the meeting.
- (2) Before entering the AGM venue, all shareholders/proxies and the attendees are required to:
  - wear a face mask;
  - use the hand sanitizer as provided;
  - undergo a compulsory body temperature screening at the venue entrance; and
  - sign a health declaration form and provide their travel history and contact details (to facilitate contact tracing, if required).

- (3) For safety purposes, the Company has the right to:
  - limit the number of physical attendees to be accommodated at the venue;
  - refuse the entry of a shareholder/proxy with high body temperature or displaying any symptoms of being unwell;
     and
  - require all shareholders/proxies and the attendees to wear a face mask throughout the AGM.
- (4) Light refreshments will be provided for members/proxy holders who attend or participate in the AGM.
